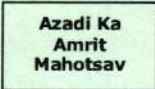

NOTE :

As per above subject and reference, from date 22.01.2021 all new Fire Safety Certificates issued (NOC)'s validity is made for 3 (Three) years and renewal Fire Safety Certificates (NOC)'s validity is made for 2(Two) years. Therefore, from this date, all NOC provided shall be considered as valid for above period. Further,

Hereafter, such new NOC to be issued for which amount was to be recovered in present, its three times i.e. against Rs.500/-, Rs.1500/- be taken as credit.

Further renewal Fire Safety Certificate(NOC)'s amount is two times of present recoverable charge i.e. against Rs.500/-, Rs.1000/- be taken as credit.

In respective category, where one year AMC was taken there hereafter in case of new NOC 3 years and in renewal case 2 years Annual Maitinence Contract(AMC) be taken.

Above order be implemented without fail.

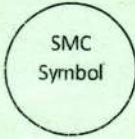

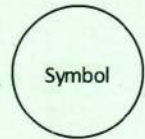

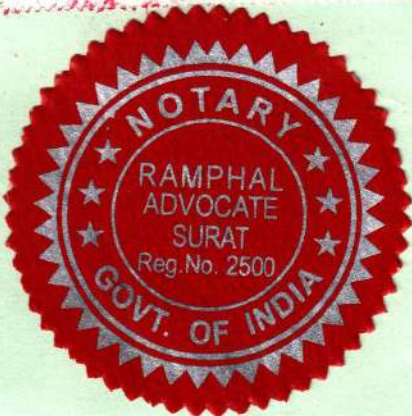
